On December 14, 2022 the New Mexico Livestock Board will, during a regularly scheduled board meeting, hold a hearing to determine if the aerial gunning of cattle in February of 2022 was commonly accepted agricultural animal husbandry practice. If it is so determined to be outside commonly accepted agricultural animal husbandry practice, the Board will determine if the action constitutes cruelty to animals and involved inhumane euthanasia practices. This hearing will be held at the Hotel Albuquerque at 1:00 PM, in Ballroom C.
